On July 27, 2019, NJDEP sent notice to Petitioner Ironbound Community Corporat the Department had received PVSC's air permit renewal application. On January 21, 2021, NJ to Petitioner ICC that the Department had received a subsequent application from PVSC to n to allow the construction and operation of the gas plant.
