**RE: Source Specific Federal Implementation Plan for Implementing Best Available Retrofit Technology for Four Corners Power Plant— Selection of Compliance Strategy**


Pursuant to 40 C.F.R. § 49.5512(i)(4), Arizona Public Service Company (“APS”) hereby notifies the U.S. Environmental Protection Agency that APS has selected the alternative Best Available Retrofit Technology (“BART”) compliance strategy set forth in Section 49.5512(i)(3) of the final Four Corners Power Plant (“FCPP” or “Plant”) BART rule. Consistent therewith, APS will retire FCPP Units 1, 2, and 3 by January 1, 2014 and comply with a BART emission limit for NO<sub>x</sub> of 0.098 lb/mmBtu (determined on a 30-boiler-operating-day rolling average basis) on FCPP Units 4 and 5 by July 31, 2018. APS plans to achieve this emission limitation through the installation and operation of selective catalytic reduction (“SCR”) control technology on these two units. APS submitted a Prevention of Significant Deterioration (“PSD”) permit application for the SCR controls on October 29, 2013 and received acknowledgment and notice of preliminary review from EPA Region 9 on November 27, 2013. APS expects EPA to issue the final PSD permit by summer of 2014, after which time APS plans to commence construction of the SCR controls.

Having secured the necessary regulatory approvals from the Arizona Corporation Commission, Federal Energy Regulatory Commission, Federal Trade Commission, and U.S. Department of Justice, on December 30, 2013, the FCPP co-owners executed a new fuel supply contract for the Plant, and APS consummated its transaction with Southern California Edison Company (“SCE”) to purchase SCE’s ownership interest in FCPP Units 4 and 5.
